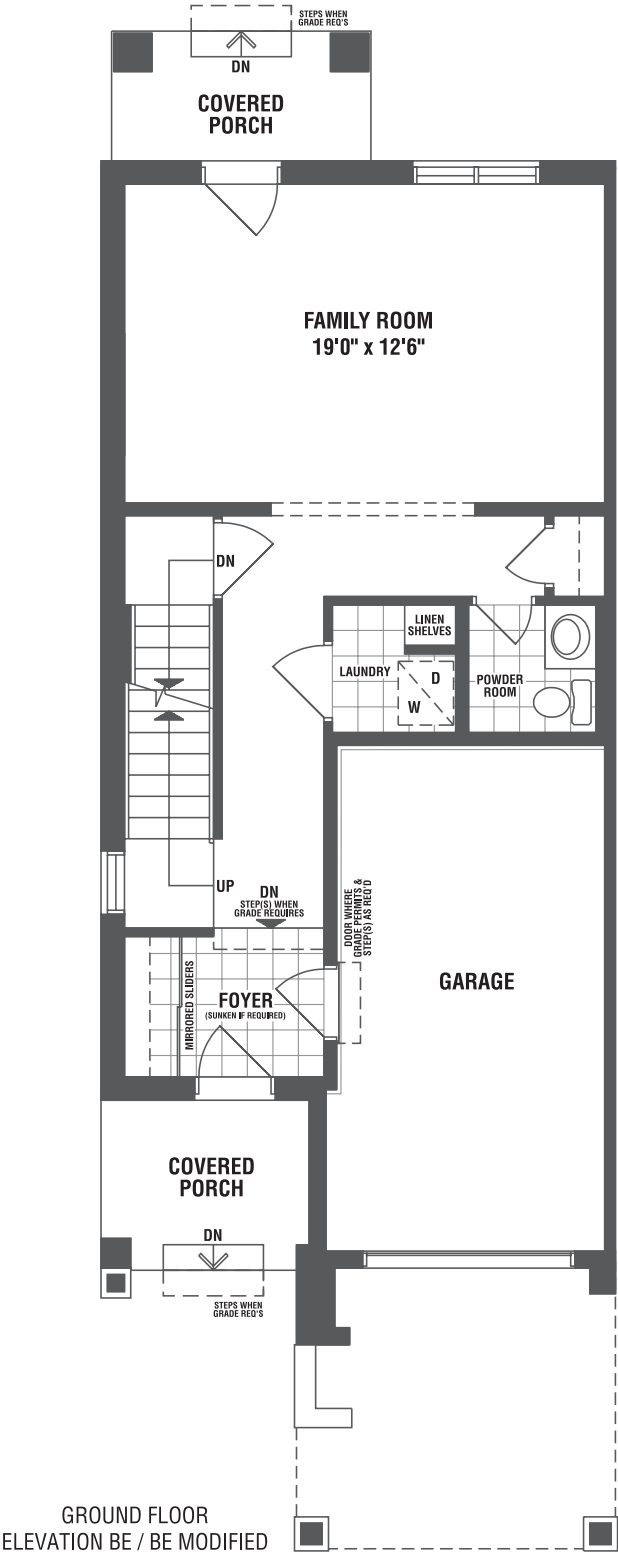

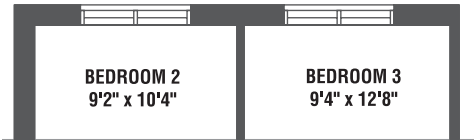




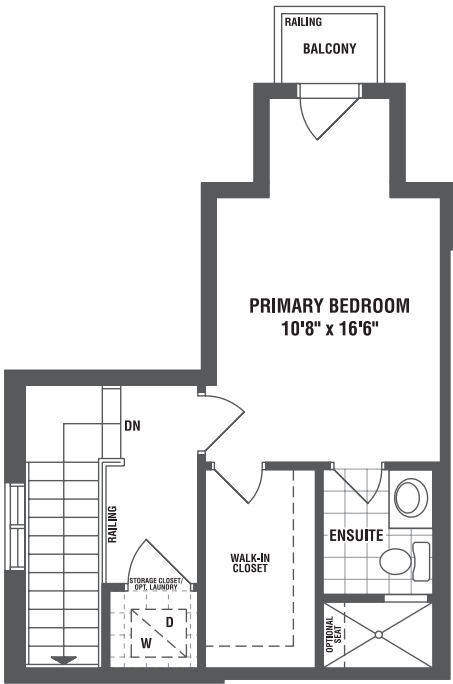
PARTIAL GROUND FLOOR
