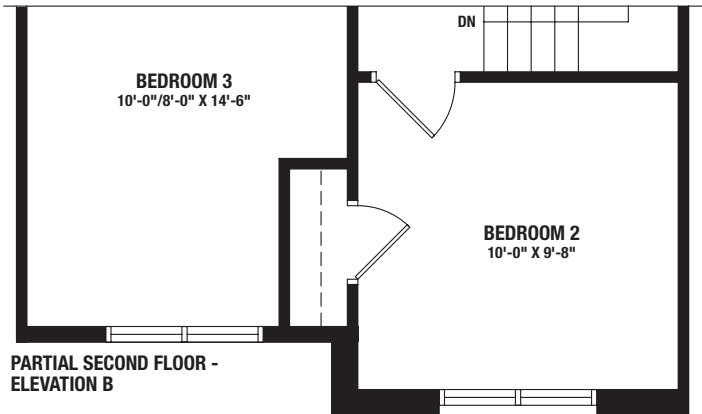

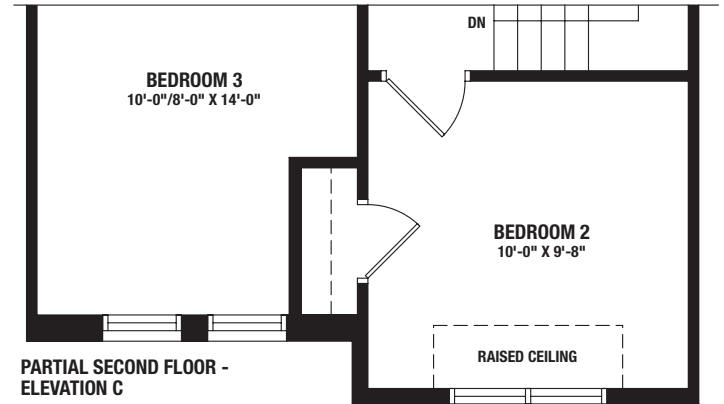
PARTIAL GROUND FLOOR - ELEVATION B



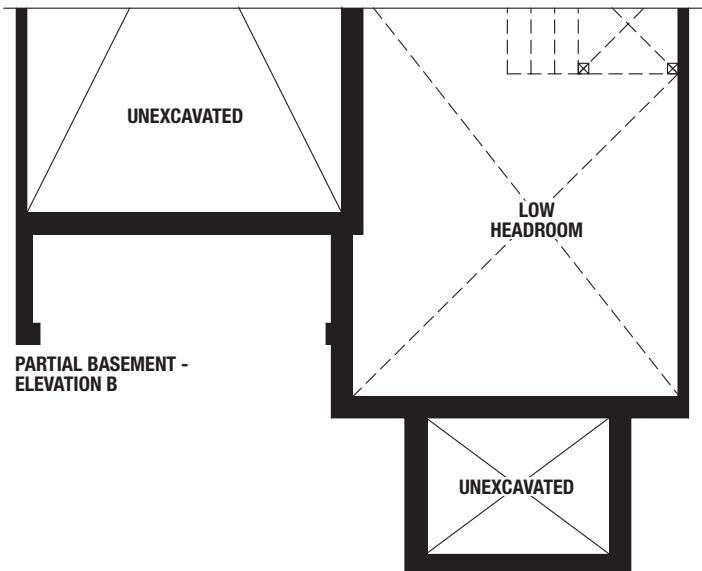
PARTIAL GROUND FLOOR - ELEVATION C



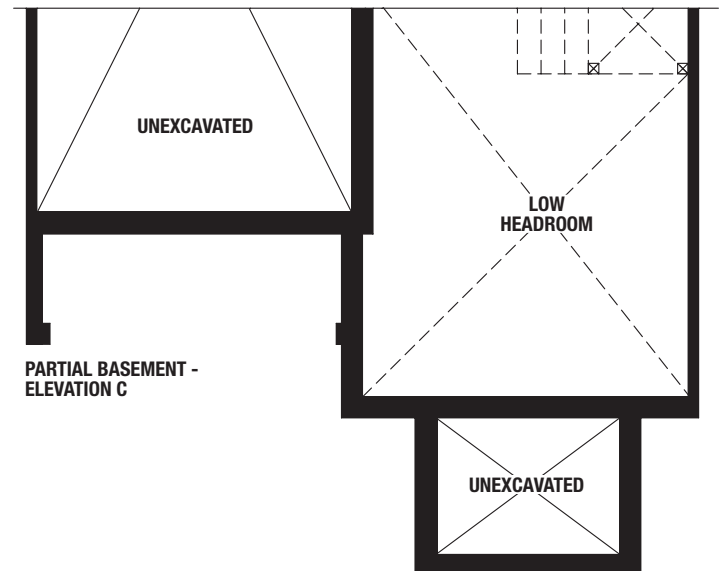
PARTIAL SECOND FLOOR - ELEVATION B
