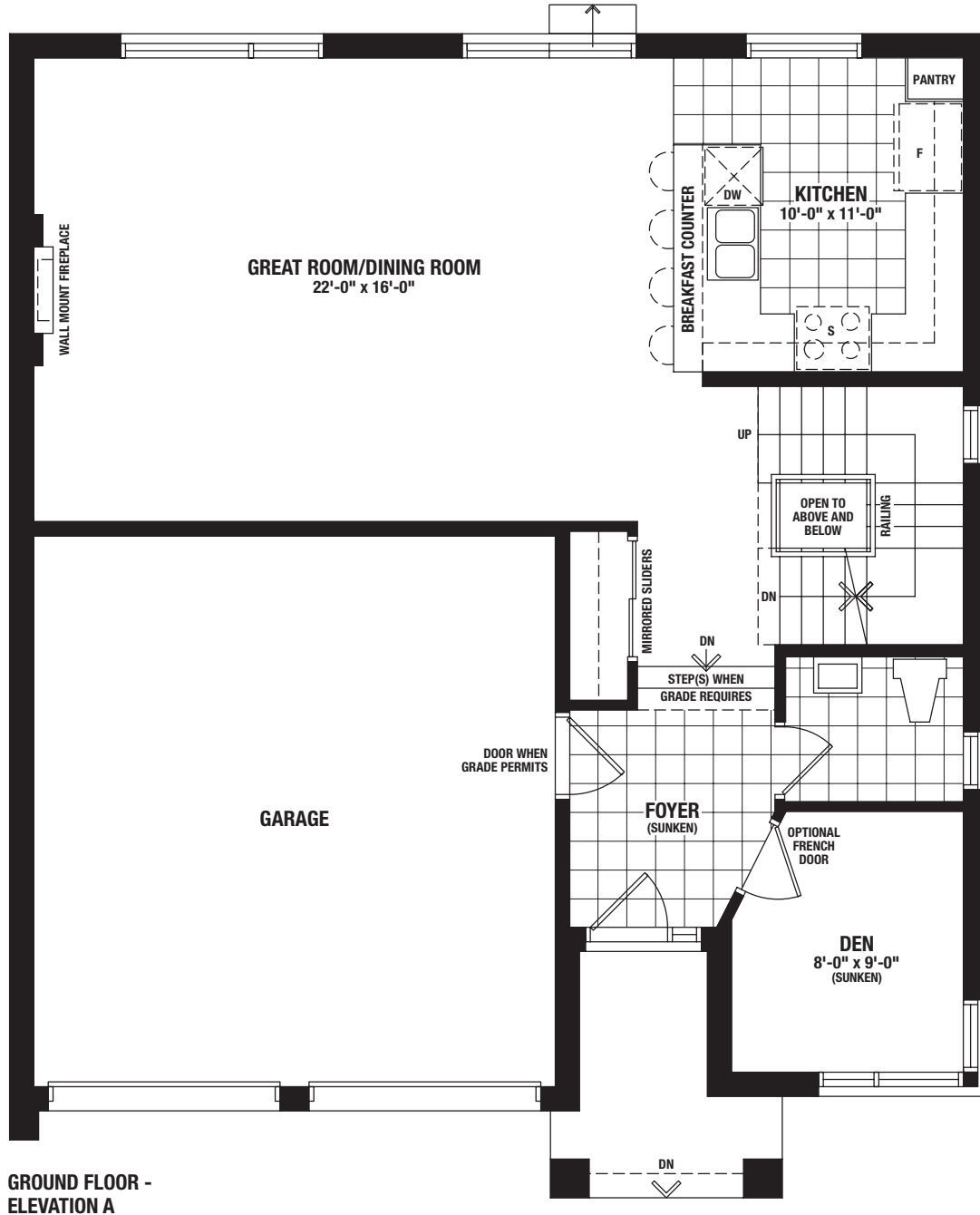

GROUND FLOOR - ELEVATION A



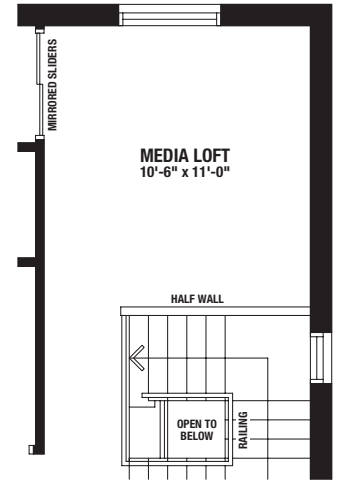
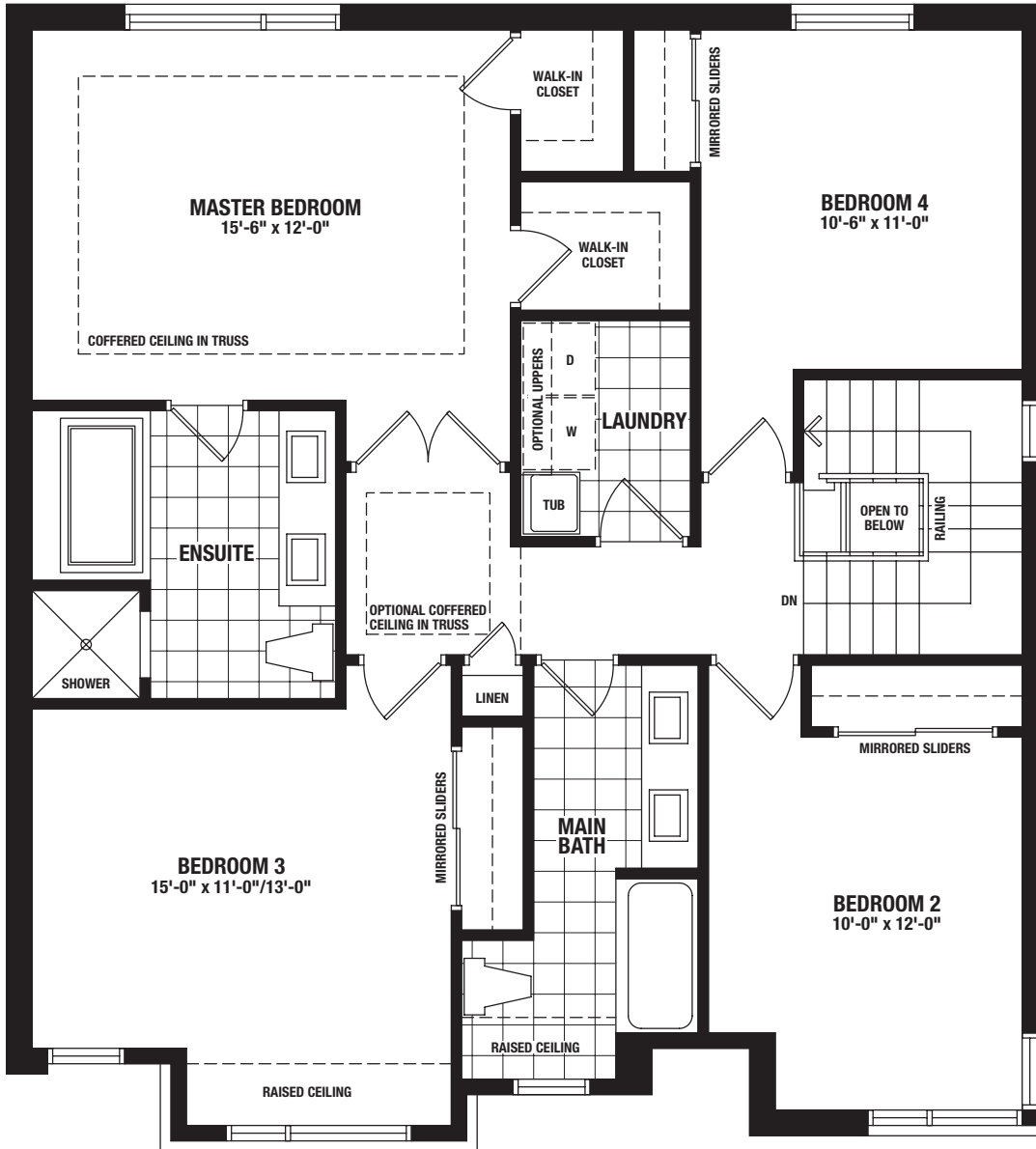

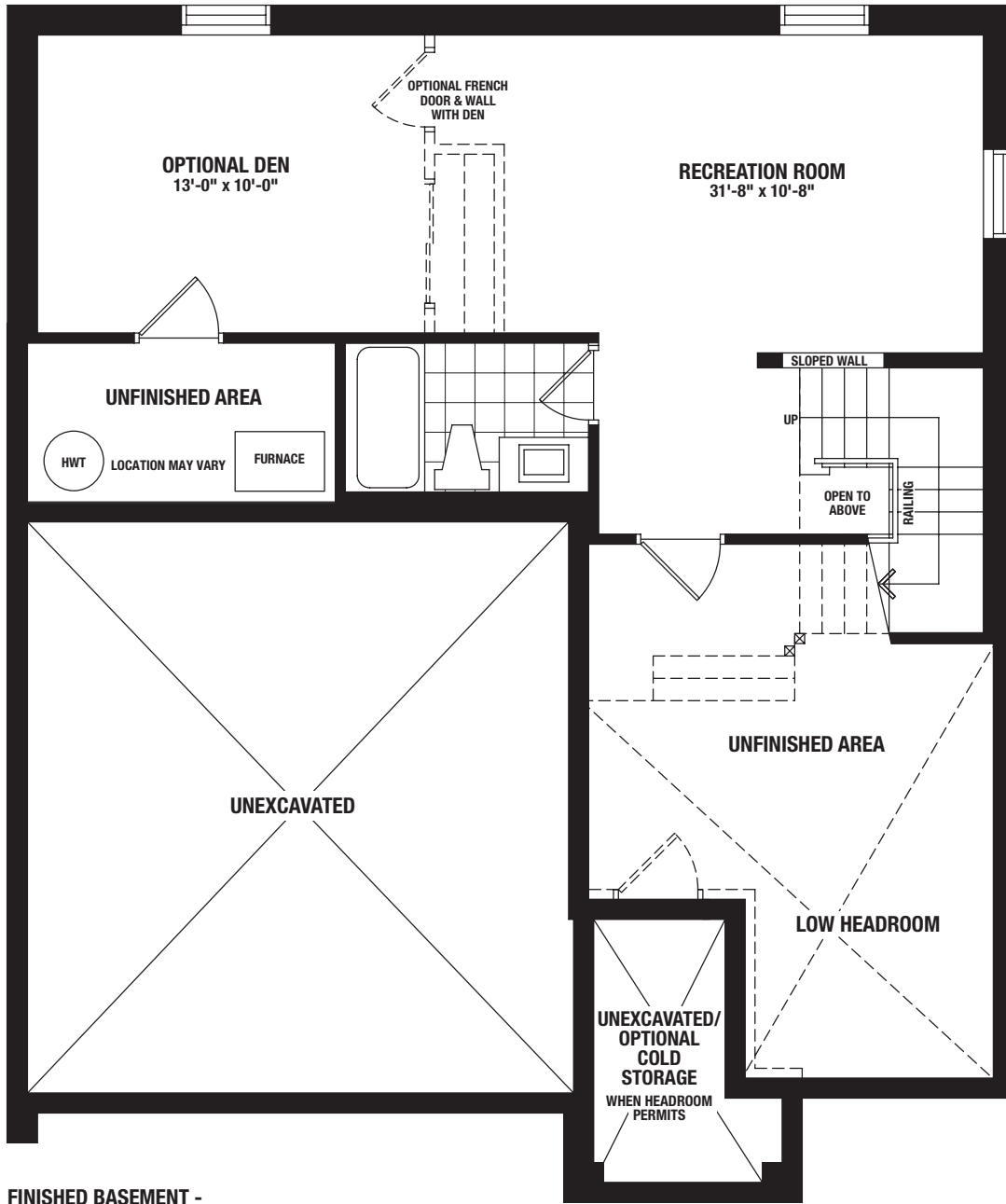

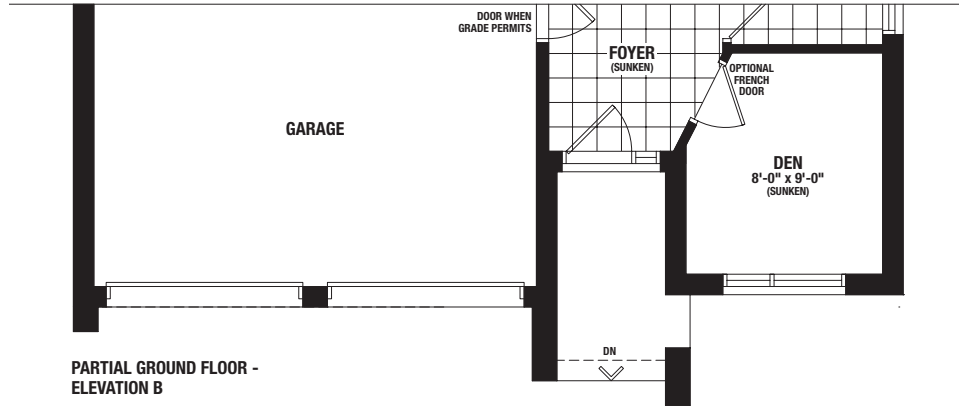

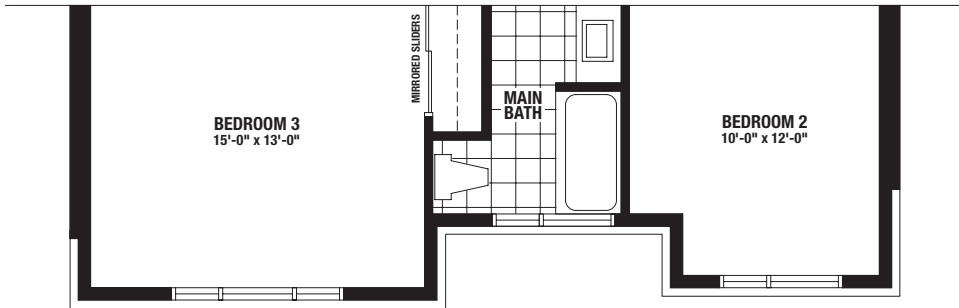

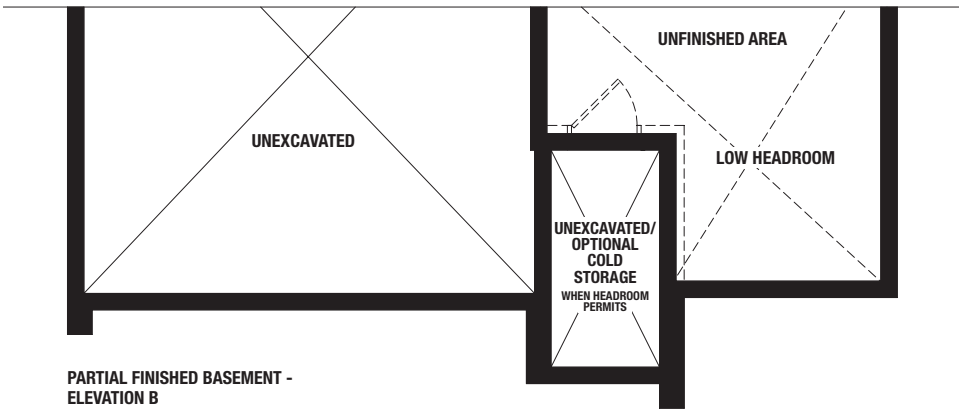
