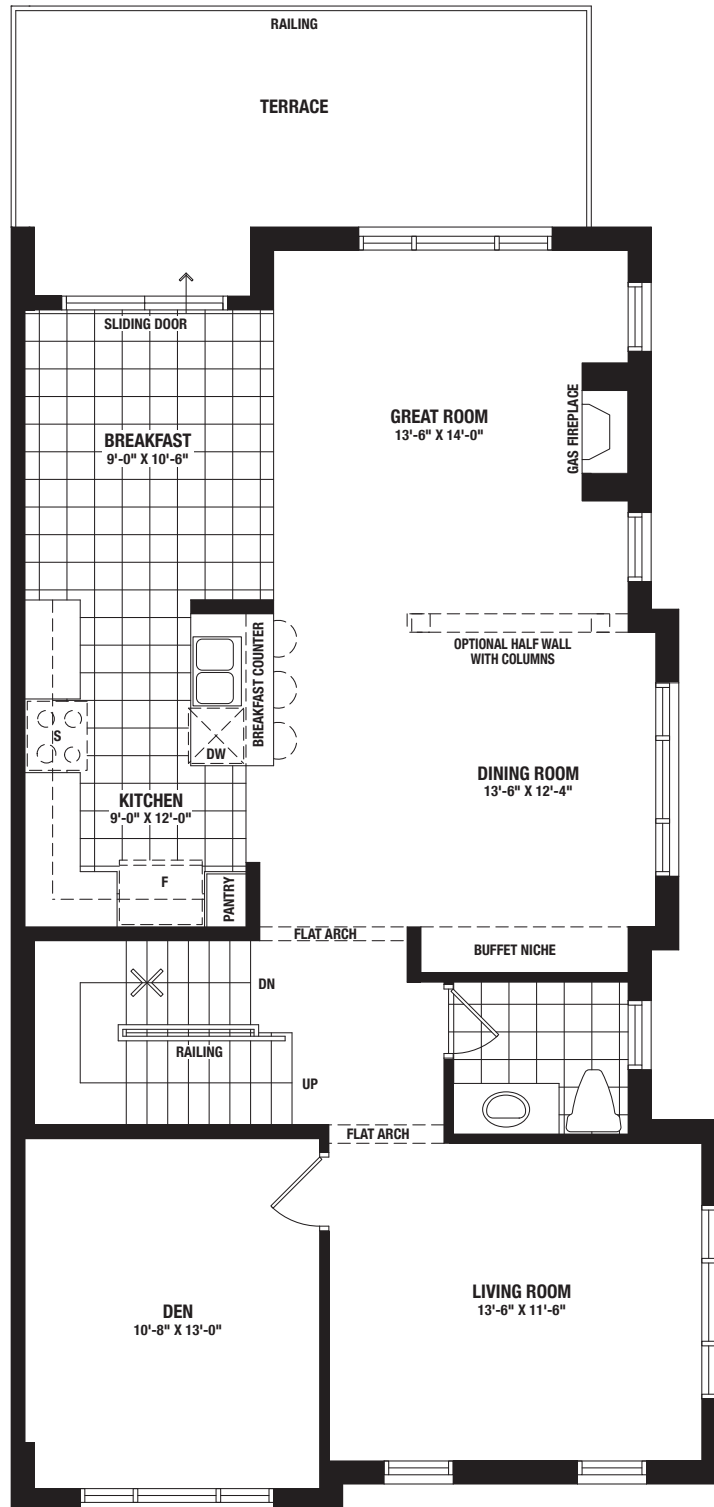

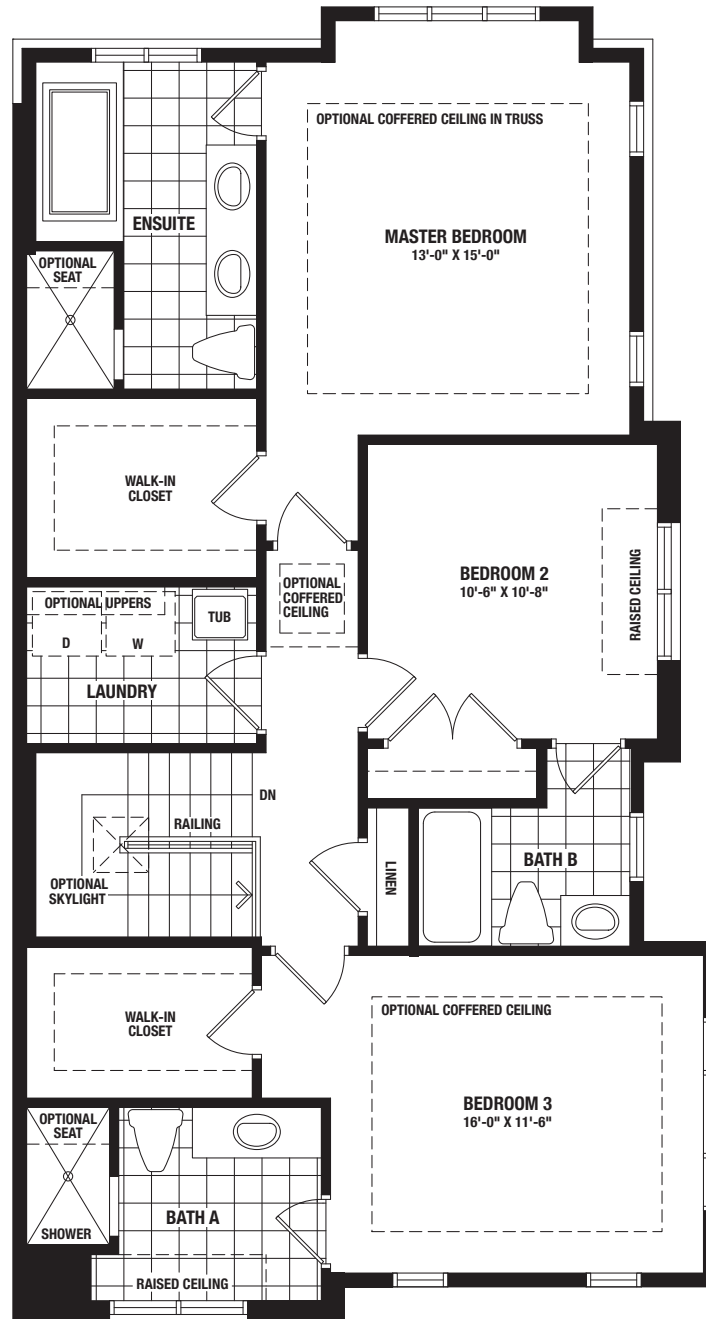

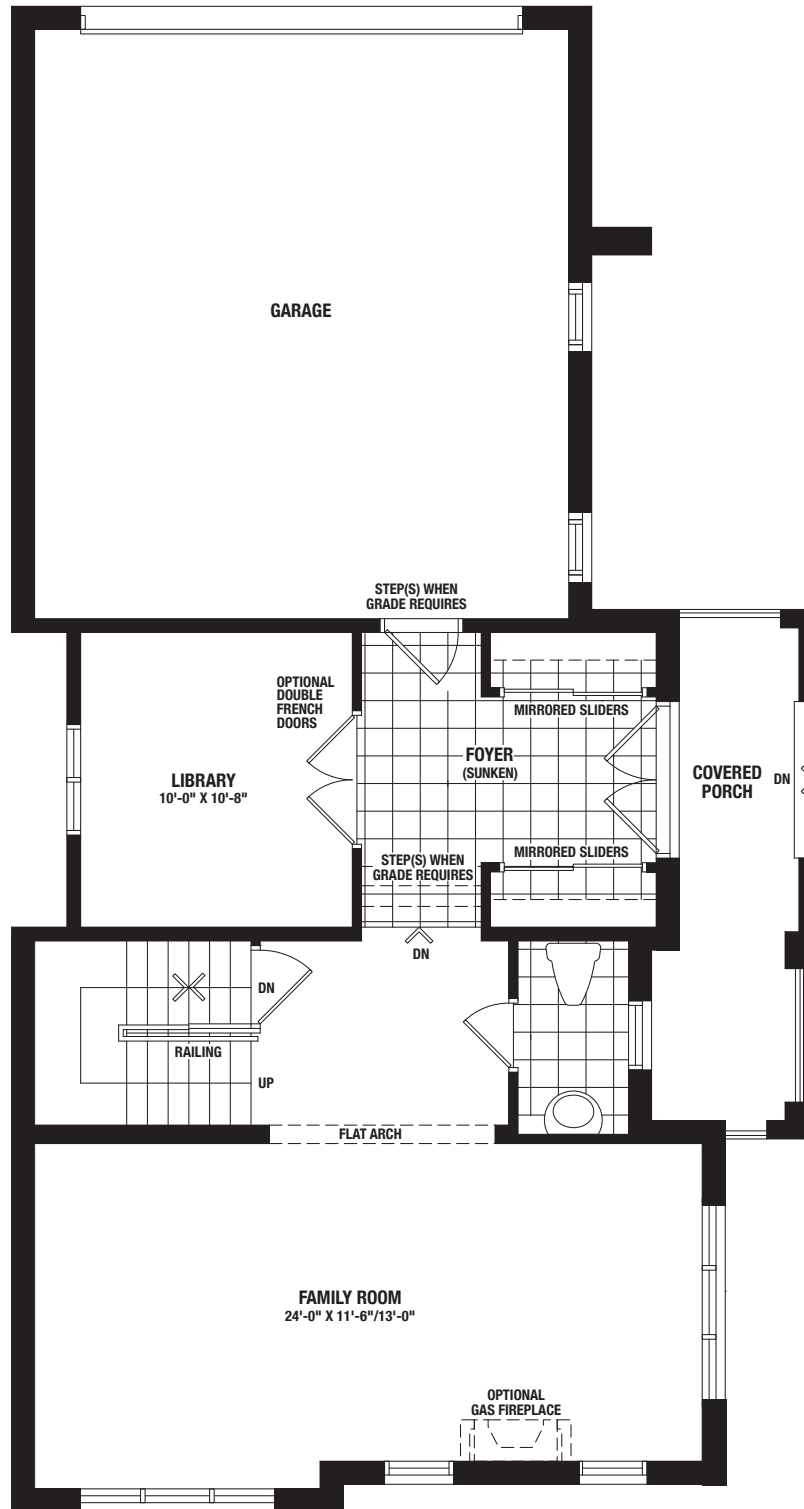

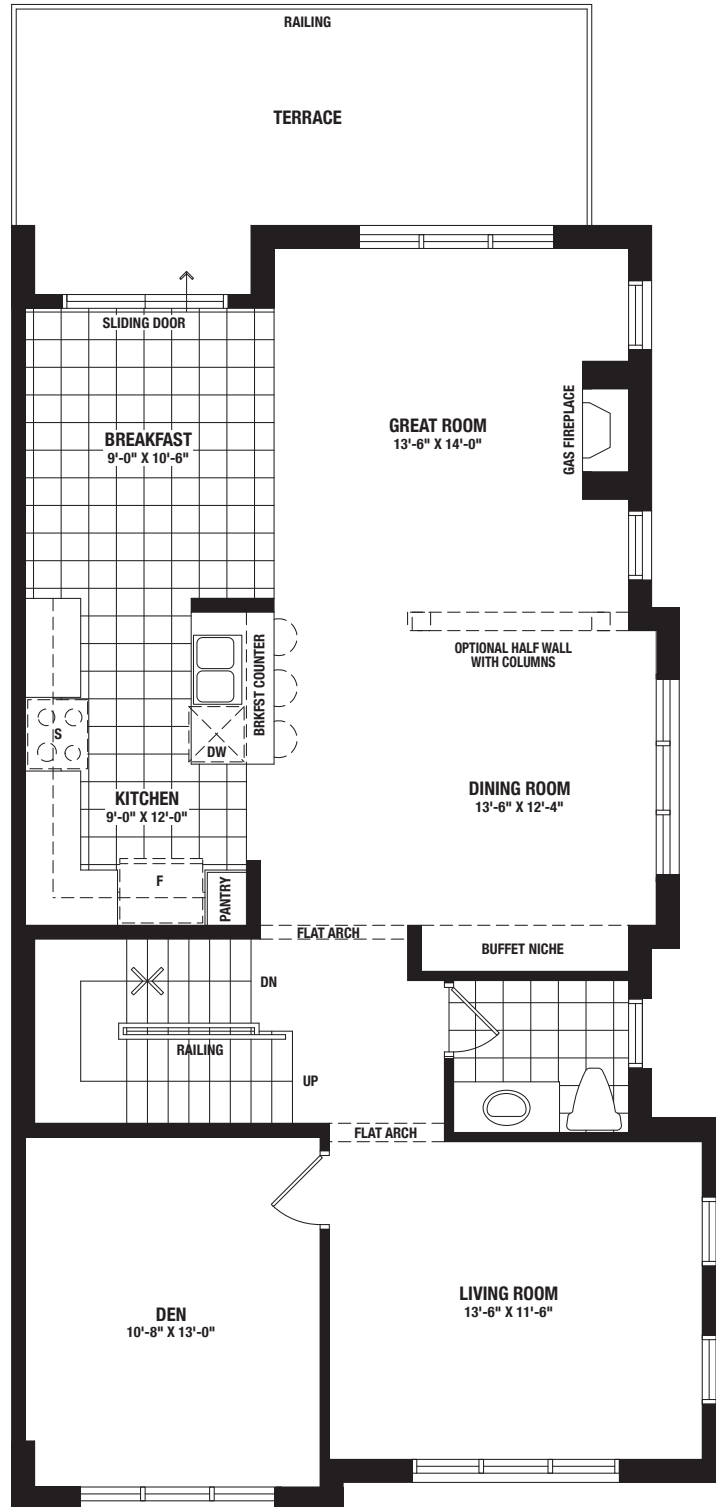

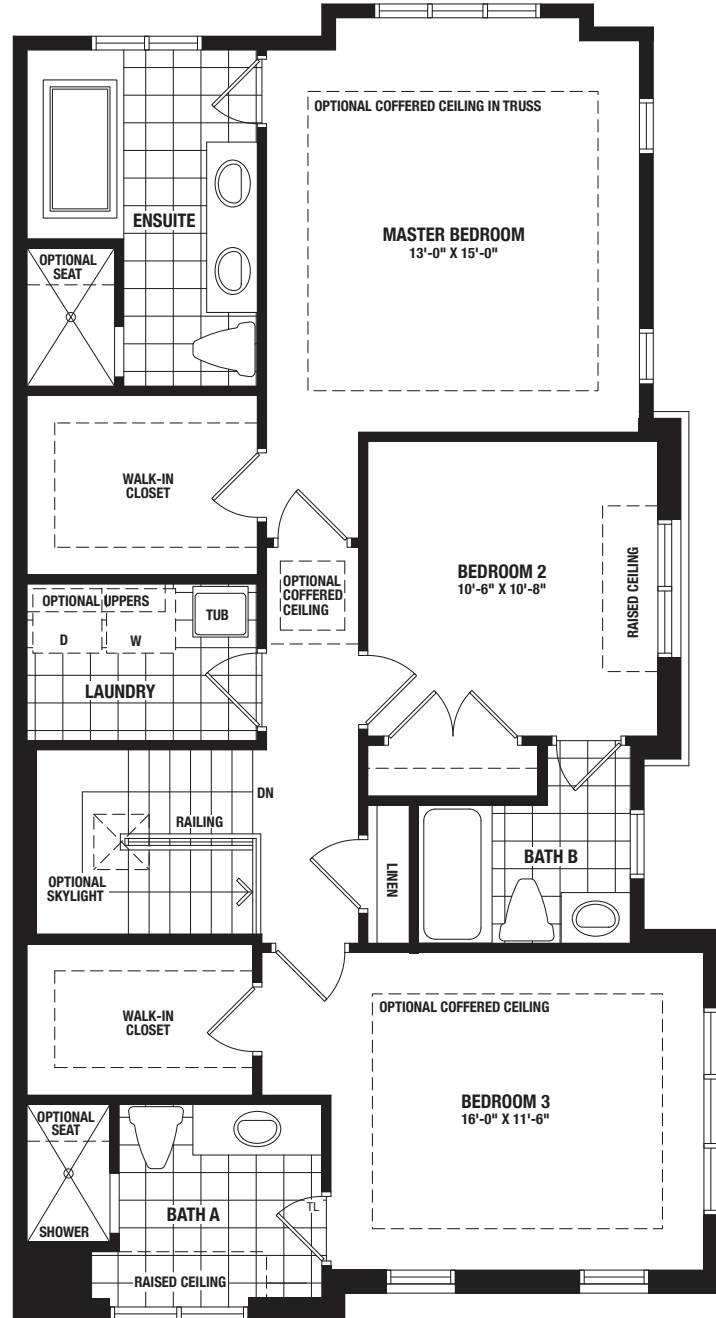

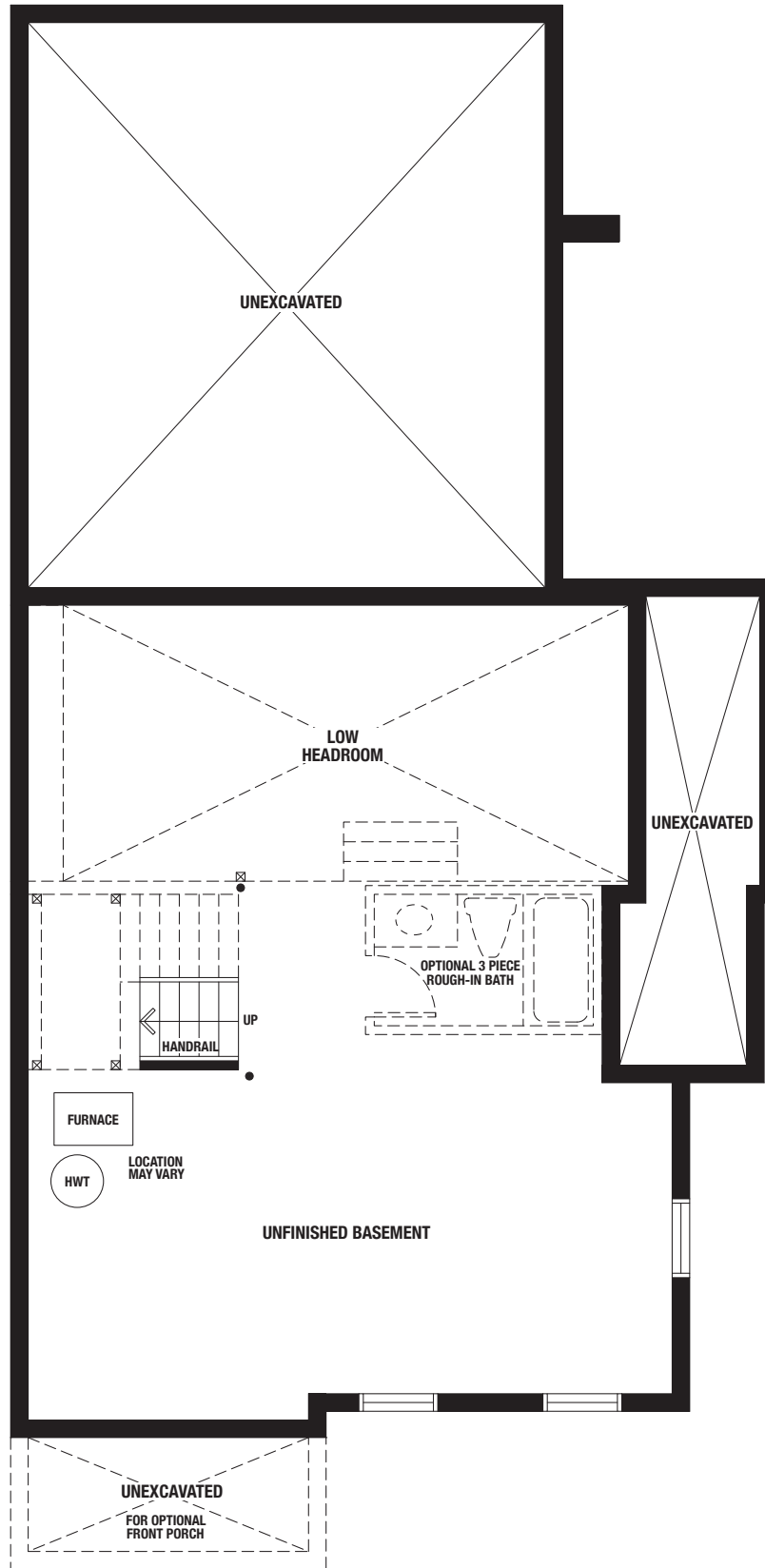

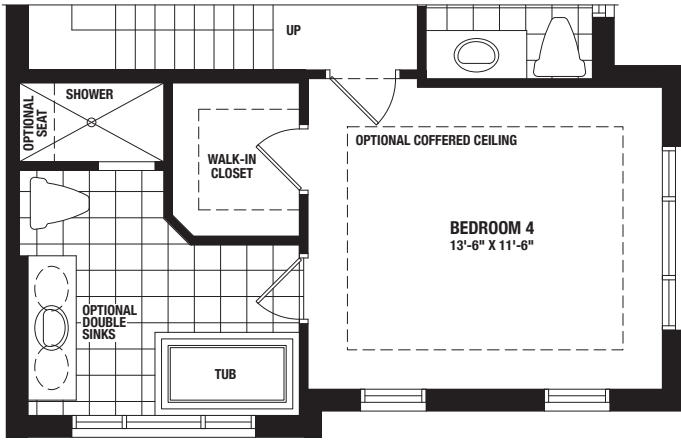

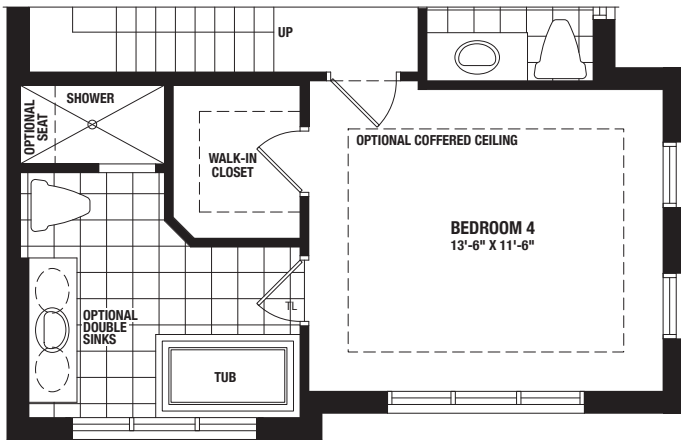

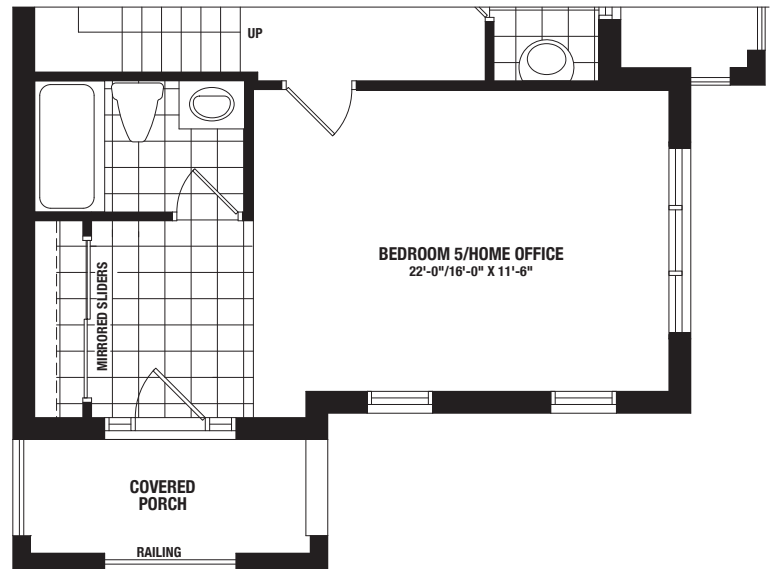
PARTIAL MAIN FLOOR - OPTIONAL BEDROOM 4
