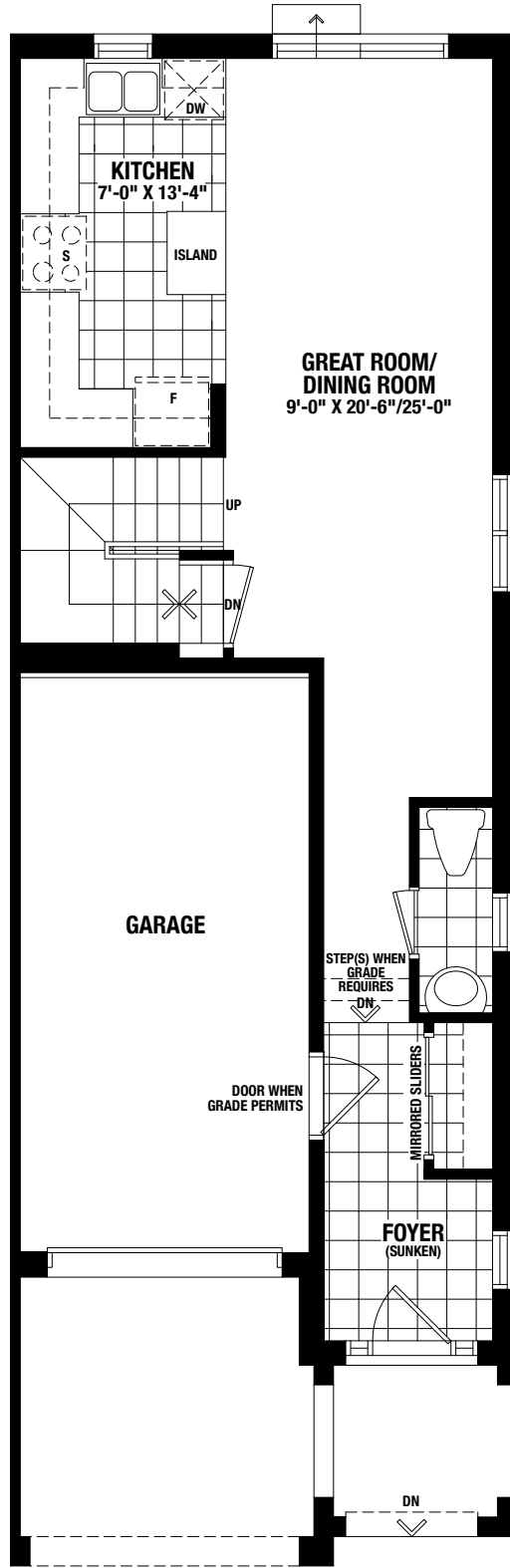

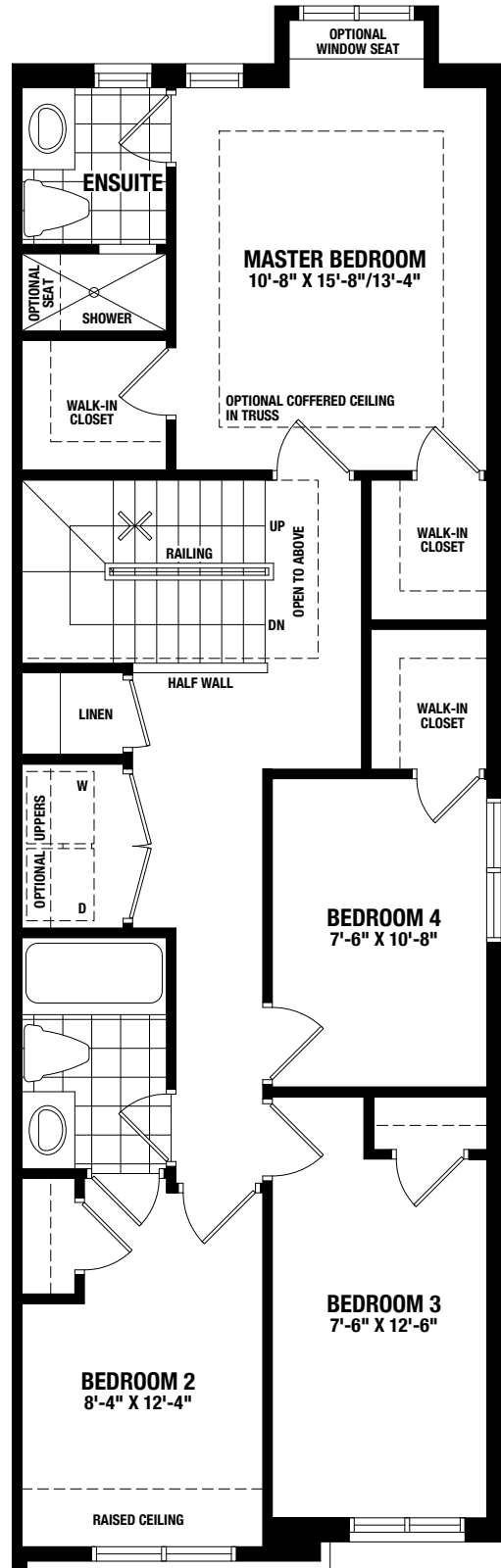


**GROUND FLOOR -

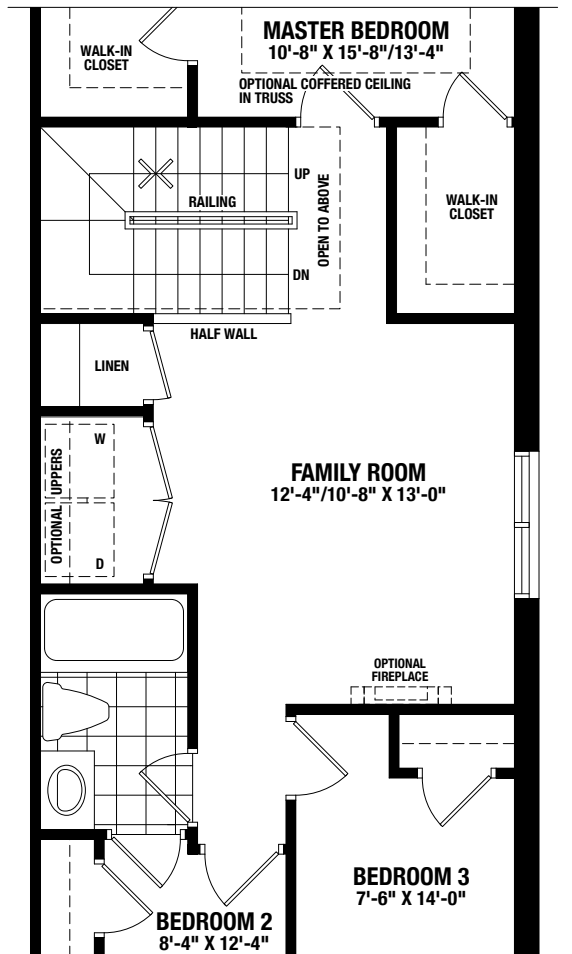
**SECOND FLOOR -
ELEVATION A**



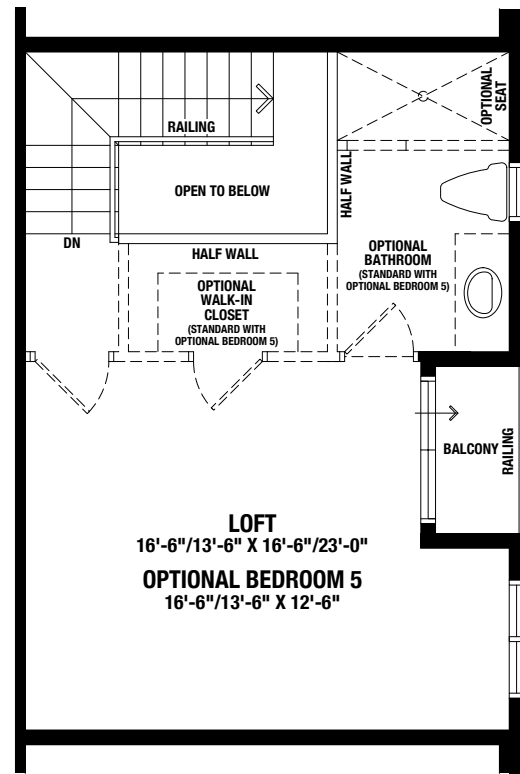

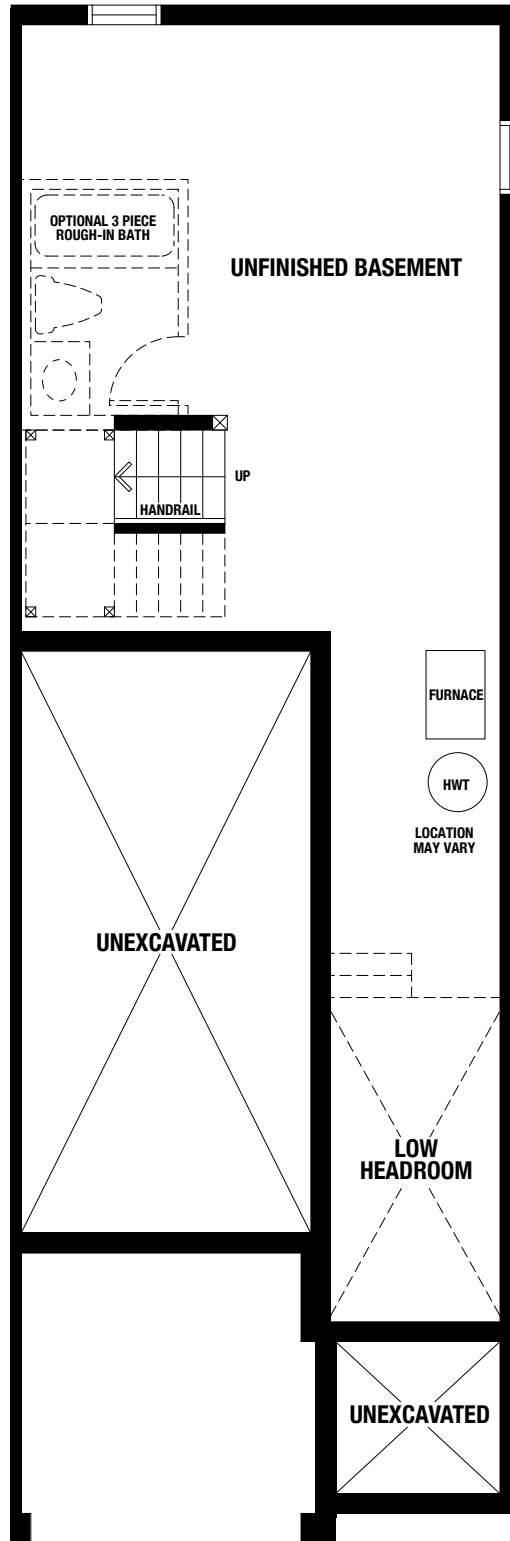

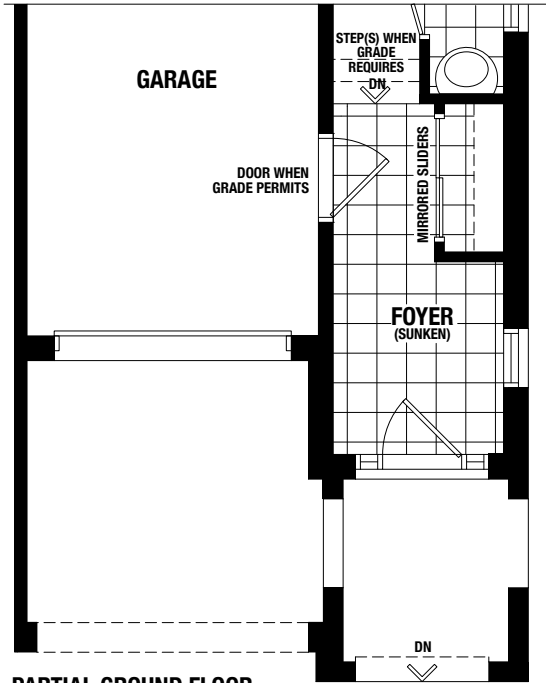

ELEVATION A**



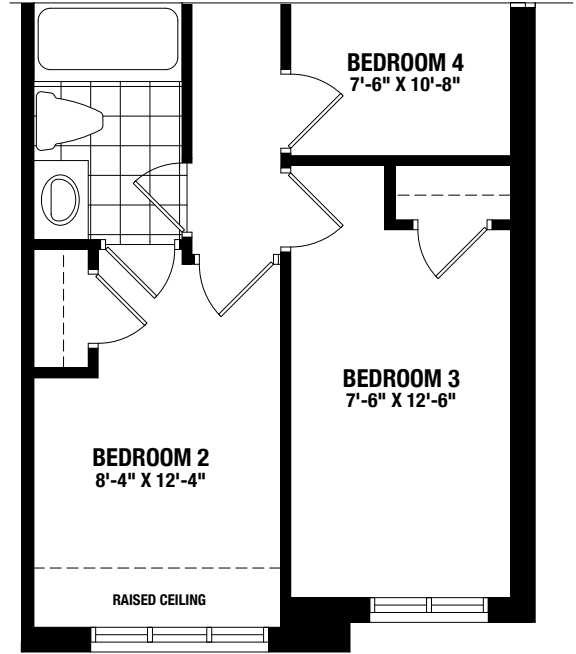

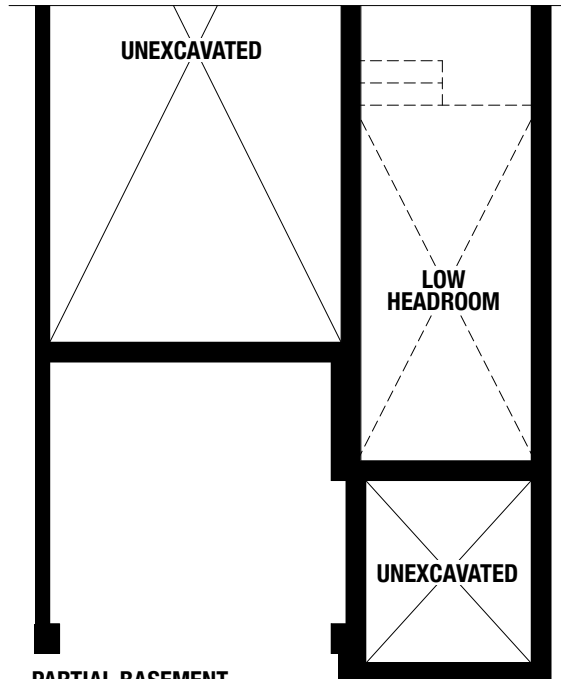
